REPORT SUMMARY**I. OBJECTIVES OF THE ACTIVITY:**

Discuss and provide materials for learning and development purposes on the topic: R.A. 11313 – Safe Spaces Act (Gender-based sexual harassment and R.A. 11648 – An Act Providing for Stronger Protection Against Rape and Sexual Exploitation and Abuse, which will enhance the participant's knowledge on the relevant laws.

II. HIGHLIGHTS OF THE ACTIVITY:

Atty. Pilipinas B. Palma, one of the Regional Gender and Development Pool of Resource Persons is the Legal Officer of the Commission on Human Rights 10 has the mastery of the subject matters and has a wide knowledge of the topics discussed. She pointed out that learning about R.A. 11313 – The Safe Spaces Act and R.A. 11648 – The Law Strengthening Protection Against Rape is relevant as they address crucial issues of Gender-Based Harassment and Sexual Exploitation. The former defines and prohibits various forms of sexual harassment in public places, online, workplaces, and educational institutions while the latter, strengthens protection against rape and sexual exploitation, increasing the age for determining statutory rape and clarifying provisions of the Revised Penal Code.

III. OUTPUT/S OF THE ACTIVITY:

Knowledge and skills gained by the participants include a clear definition of GBSH, expanded understanding of protecting safe spaces in public spaces, workplaces, educational institutions and online thereby preventing GBSH from happening. Further, knowledge of the participants were enhanced when the Revised Penal Code was discussed with regard to rape and sexual exploitation cases. Power Point Presentations (PPT) will be provided to all participants to be released to all Field Operating Units.

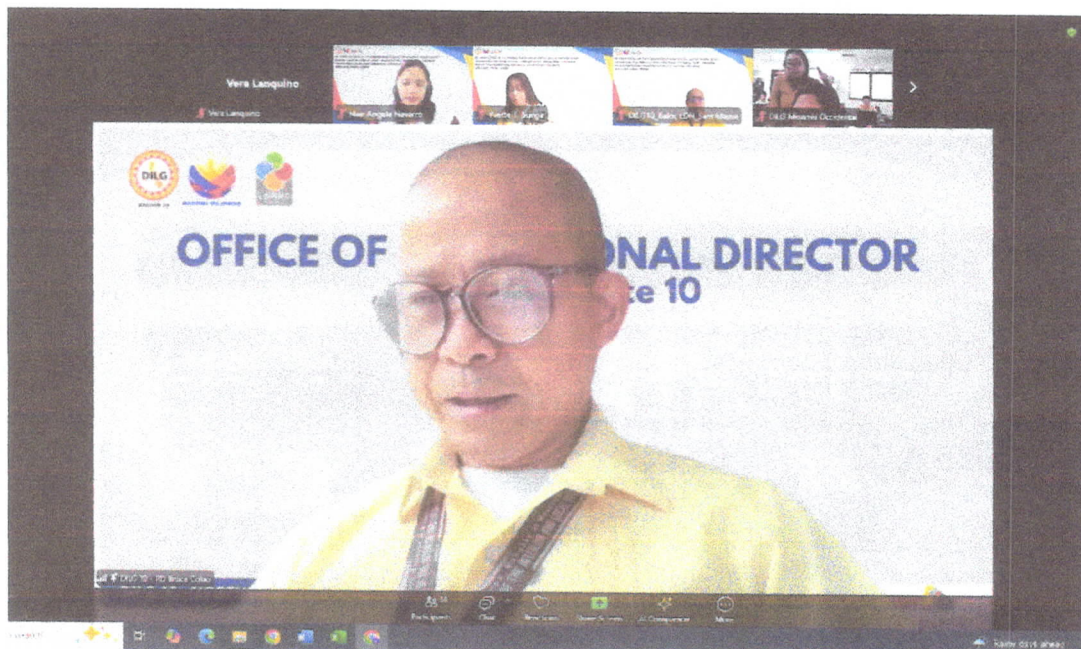
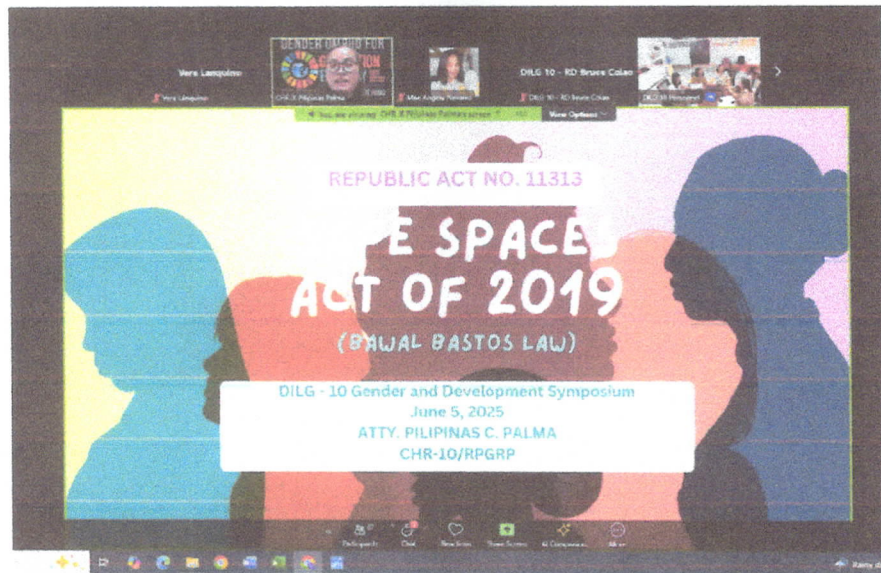
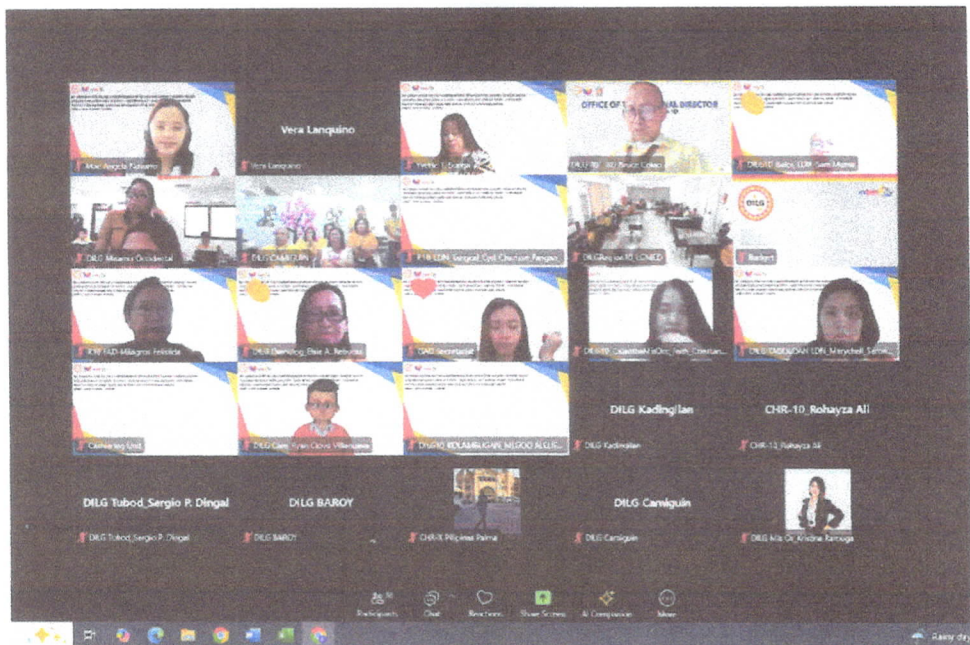
